AN ORDINANCE CALLING A SPECIAL ELECTION ON A BUSINESS LICENSE  
FEE QUESTION IN WOOD HEIGHTS, MISSOURI

BE IT ORDAINED BY THE BOARD OF ALDERMAN OF WOOD HEIGHTS,  
MISSOURI, AS FOLLOWS:

SECTION 1. THE BOARD OF ALDERMAN FINDS IT NECESSARY AND HEREBY  
DECLARES ITS INTENT TO IMPOSE A BUSINESS LICENSE FEE IN THE AMOUNT  
OF \$35.00.

SECTION 2. A SPECIAL ELECTION IS HEREBY ORDERED TO BE HELD IN  
WOOD HEIGHTS, MISSOURI, CONCURRENTLY WITH THE MUNICIPAL ELECTION ON  
TUESDAY, APRIL 6, 1999, ON THE FOLLOWING QUESTION:

SHALL WOOD HEIGHTS, MISSOURI, IMPOSE A BUSINESS  
LICENSE FEE IN THE AMOUNT OF \$35.00?

SECTION 3. THE FORM OF NOTICE OF SPECIAL ELECTION SHOWING SAID  
QUESTION, A COPY OF WHICH IS ATTACHED HERETO AND MADE A PART  
HEREOF, IS HEREBY APPROVED.

SECTION 4. THE CITY CLERK IS HEREBY AUTHORIZED AND DIRECTED TO  
NOTIFY THE COUNTY CLERK OF RAY COUNTY, MISSOURI, OF THE PASSAGE OF  
THIS ORDINANCE NO LATER THAN 5:00PM ON TUESDAY, JANUARY 26,  
1999.

SECTION 5. THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT  
FROM AND AFTER ITS PASSAGE AND APPROVAL.
